Study Regulations for the Bachelor's program in International Management

Amended version

Adopted by the Faculty Council of the Faculty of Business Management and Social Sciences on October 5, 2022, approved by the University Steering Committee on October 19, 2022, published on January 29, 2024 with effect from September 1, 2024

Section 1

Reference to Other Regulations

These Study Regulations contain the essential binding provisions for the regular study of the degree program in International Management in conjunction with the Program-Specific Examination Regulations for this degree program, the Language Module Regulations of the Faculty of Business Management and Social Sciences, and the General Examination Regulations of Osnabrück University of Applied Sciences. They define the binding structure and content of the study program, and especially the module titles, the semester in which each module should be taken, the number of graded exams, the types of exam available for selection, and the credit points earned.

§ 2 Type and Scope of Exams

- (1) The type and number of graded and ungraded exams and the associated examination requirements of the first stage are set forth in Appendix 1.
- (2) The type and number of graded and ungraded exams and the associated examination requirements of the second stage are set forth in Appendix 2.
- (3) The type and number of graded and ungraded exams and the associated examination requirements for the optional offer of specialisations in the Bachelor's program in International Management are set forth in Appendix 3.

Section 3 Study Abroad Semester

¹For the purposes of a semester abroad, several modules can be combined and recognized as a package under the Learning Agreement (LA), depending on the courses offered by the partner university. ²This approach involves determining average grades from the partial performances included, as long as individual grades can be converted.

Section 4 Transitional Arrangement

¹Students who enroll by the summer semester 2024 can graduate by the end of the winter semester 2028/2029 under the previous Examination and Study Regulations. ²Students may switch to these Examination and Study Regulations on request, although graded exams will only be offered successively from the winter semester 2024/2025 according to the program schedule. ³The request must be submitted in writing to

the Office of the University Registrar at least one month before the end of the semester for the following semester. ⁴At the end of the transitional period, students will be automatically transferred to these Examination and Study Regulations. ⁵Students who are enrolled in an advanced semester according to section 6 of the Lower Saxony University Admissions Act (*Niedersächsisches Hochschulzulassungsgesetz* – NHZG) are subject to the Study and Examination Regulations that apply to students who are in this semester according to the regular program schedule of the standard period of study and who have not exercised their right to request a switch.

§ 5 Entry into Force

¹These regulations shall enter into force on the day after their publication in the Official Gazette of Osnabrück University of Applied Sciences with effect from the winter semester 2024/2025. ²The Study Regulations of July 5, 2017, in the version with the first amendment order of September 13, 2019, will no longer apply to this degree program at the end of the transitional period.

The portfolio exam PFP-2 covers 100 points and consists of one written exam (K1) and one oral exam (M). Each element is weighted with 50 points (50 percent). (Individual parts: K1 + M; points: 50 + 50). Portfolio exam for Chinese level A1:

The portfolio exam PFP-1 covers 100 points and consists of two written exams (30 minutes each), one presentation (PR), and one oral exam (M). Each written exam is weighted with 30 points (30 percent). The presentation and the oral exam are weighted with 20 points (20 percent) each. (Individual parts: K30 + K30 + PR + M; points: 30 + 30 + 20 + 20).

The portfolio exam PFP-2 covers 100 points and consists of one written exam (K1), one presentation (PR), and one oral exam (M). The written exam is weighted with 50 points (50 per cent). The presentation and the oral exam are weighted with 25 points (25 percent) each. (Individual parts: K1 + PR + M; points: 50 + 25 + 25). Portfolio exam for Russian level A2:

PFP-1: The portfolio exam covers 100 points and consists of one written exam (K1) and one oral exam (M). K1 and M are weighted with 50 points (50 percent) each.

PFP-2: The portfolio exam covers 100 points and consists of one written paper (HA) and one presentation (PR). HA and PR are weighted with 50 points (50 percent) each.

PFP-3: The portfolio exam covers 100 points and consists of two written exams (30 minutes each) and two oral exams (M). The individual parts are weighted with 25 points (25 percent) each.

Portfolio exam for Spanish level B1:

The portfolio exam covers 100 points and consists of two written exams (40 minutes each), one presentation (PR), and one oral exam (M). Each K40 is weighted with 25 points (25 percent). PR is weighted with 30 points (30 percent) and M is weighted with 20 points (20 percent).

- ³⁾ As a rule, students will only be admitted to the module "Business Mathematics" if they have passed either the placement test or the preparatory course mathematics.
- ⁴⁾ As a rule, students will only be admitted to a level of a foreign language course if they have passed the preceding course level (prerequisite) or if their initial placement test has shown the relevant results. Students can select their

foreign business language from the following offer: Chinese, French, Spanish, Russian. International students (i.e. students who have obtained their school leaving certificate or university degree abroad) choose German if they do not have proven study competence (level B2 CEF) in German by means of one of the internationally recognized language certificates (e.g. by the Goethe-Institut). Other languages can be taken as additional languages if they are necessary for the partner university to study abroad and/or replace the aforementioned on application and subject to approval by the Academic Dean. If Chinese or Russian is chosen, only the modules at level A1 (Chinese) or A2 (Russian) have to be completed. International students take German at level B1.1.

- ⁵⁾ There are no admission requirements for the module "Financial Statements (IFRS)".
- ⁶⁾ The portfolio exam covers 100 points and consists of one report (R) and a one-hour written exam (K1). The report and the exam are weighted with 50 points each.
- ⁷⁾ The portfolio exam covers 120 points and consists of a one-hour written exam (K1) and a final one-hour written exam (K1). Each K1 is weighted with 60 points.
- ⁸⁾ The portfolio exam covers 100 points and consists of one presentation (PR) and a one-hour written exam (K1). The presentation and the exam are weighted with 50 points each.

Students who have chosen a specialisation in the field of business management or economics at Osnabrück University of Applied Sciences can select modules under the electives abroad in an interdisciplinary manner.
- ⁸⁾ Regular participation in two block seminars at the students' option. At least one block seminar has to be of the kind "international". The regular participation in an International Summer University abroad that is credited with 5 ECTS

credits replaces the participation in two block seminars. Alternatively, a module that is comparable in terms of learning objectives and that is credited with 5 ECTS credits can be recognized, e.g. the International Summer University (ISU) at Osnabrück University of Applied Sciences.

- ¹⁰⁾ The number of contact hours per week varies according to the individual consultation per student.
- ¹¹⁾ The "Internship and Academic Project" is a compulsory 12-week internship. The internship can exceptionally be a practical project work to be agreed with the examiner.
- ¹²⁾ The portfolio exam covers 100 points and consists of a one-hour written exam (K1) and a final one-hour written exam (K1). Each K1 is weighted with 50 points.
- ¹³⁾ The portfolio exam covers 100 points and consists of one written paper (HA) and a one-hour written exam (K1). The written paper and the exam are weighted with 50 points each.

Organization of semester 5 (semester abroad):

As a rule, semester 5 is scheduled as the study semester abroad and is compulsory for both German students and students who have obtained their higher education entry qualification in Germany as well as foreign students. Level B2 of the language of instruction at the chosen foreign university has to be completed as an admission requirement. Foreign students may be allowed to spend this semester at Osnabrück University of Applied Sciences if a substantiated application to that effect is submitted and if they prove to be sufficiently competent in German.

During their study semester abroad at a partner or non-partner university, students need to select modules with a credit point value to the equivalent of 25 ECTS credits altogether. In their semester abroad, students complete electives covering 20 ECTS credits as well as the third module of their individually selected specialisation covering 5 ECTS credits.

The Electives Abroad covering 20 ECTS credits shall be advanced modules from the field of business management or economics (including modules relating to social and cultural sciences) according to the students' choice and offer of the foreign university. Students who have chosen a Business Language as their specialisation at Osnabrück University of Applied Sciences have to choose specific modules of one discipline in business management or economics (for example in the field of "Marketing") to the extent of approximately 15 ECTS credits (equaling a specialisation) from the overall 20 ECTS credits which have to be completed. Students who have chosen a specialisation in the field of business management or economics at Osnabrück University of Applied Sciences can select all the modules under the electives abroad in an interdisciplinary manner.

The third module of the specialisation, which is individually selected by the students at Osnabrück University of Applied Sciences, is completed in the semester abroad. Students choose a module supplementing the contents of the specialisation selected according to the offer of the foreign university. 5 ECTS credits are allocated to this specialisation module by Osnabrück University of Applied Sciences.

The modules to be completed in the semester abroad are to be agreed with the Faculty and fixed in a Learning Agreement. As a minimum requirement, 20 ECTS credits have to be obtained abroad for the study semester abroad to be regarded as passed.

Exceptions to the above regulations may be granted by the Academic Dean.

PFP-2: The portfolio exam covers 100 points and consists of one written exam (K20), one written exam (K90 minutes), and one presentation (PR). K20 is weighted with 20 points, K90 is weighted with 60 points, and PR is weighted with 20 points.

- 22) Portfolio exam for French level B2 and C1.1: The portfolio exam covers 100 points and consists of one presentation (PR), one oral exam (M), one written work sample (APS), and one written exam (K1). PR and M are weighted with 25 points (25 percent). APS is weighted with 20 points (20 percent) and K1 is weighted with 30 points.
- ²³⁾ PFP-3: The portfolio exam covers 120 points and consists of two written exams (40 minutes) and one presentation (PR). The written exams and the PR are weighted with 40 points each.
