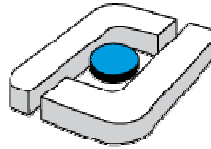
Auslandsstudiensemester

- 4) As a rule, students will only be admitted to the module "Business Mathematics" if they have passed either the placement test or the preparatory course mathematics.
- 5) As a rule, students will only be admitted to the module "Financial Accounting" if they have passed either the placement test or the preparatory course accounting.
- 6) As a rule, students will only be admitted to a level of a foreign language course if they have passed the preceding course level (prerequisite) or if their initial placement test has shown the relevant results.

- 2) The specialization covers six modules with 5 ECTS credits each. Students choose from the following nine modules offered: International Human Resource Management, Global Marketing Management, International Logistics, Management Accounting, Corporate Finance, Global Economics, Advanced English Business Conversation and Negotiation (CEF C1/C2), Cultural Management. As optional extra, the module „Procurement and Production Logistics“ can be chosen as part of the specialization, if taught in English (this module belongs to the specialization Procurement and Production Management under the bilingual Bachelor programme International Business and Management).
- 3) in accordance with the course offer of the partner university
- 4) The language examination is split in written examination and oral examination. The respective type of the examination in the foreign language chosen is specified in the module data bank.
- 5) Once the examination for the module Business Language 2 Level 4 has been attempted, this language is automatically deemed to be 'Business Language 2' unless an application to the contrary was submitted prior to the completion of the module. Foreign students have to choose German as their second business language if they do not have proven study competence (level 4) in German by means of one of the internationally recognized language certificates (e. g. by Goethe institute).
- 6) As a rule, students will only be admitted to a level of a foreign language course if they have passed the preceding course level (prerequisite) or if their initial placement test has shown the relevant results.

Organisation of Semester 5 (semester abroad):

As rule, semester 5 is scheduled as the foreign study semester and is compulsory for both German students and students who have obtained their higher education entry qualification in Germany and foreign students respectively. Level 4 of the language of instruction at the chosen foreign university has to be completed as an admission requirement. Foreign students may be allowed to spend this semester at Hochschule Osnabrück if a substantiated application to that effect is submitted and if they prove to be sufficiently competent in German.

During their foreign study semester at a partner university, students need to select modules with a credit point value to the equivalent of 30 ECTS. 15 ECTS cover the specialisation abroad consisting of advanced modules of a special field and according to the course offer of the respective university. Another 15 ECTS are covered through electives with an international dimension. Both choices are made at the discretion of the student and are then to be agreed with the Faculty and fixed in a Learning Agreement.

Students completing their foreign study semester at HS Osnabrück (see above) have to complete their specialization covering 15 ECTS as well as electives totalling 15 ECTS.

Exceptions to above regulations may be granted by the Dean of Studies.
