Language Module Regulations of the Faculty of Business Management and Social Sciences

Amended version

adopted by the Faculty Council of the Faculty of Business Management and Social Sciences on May 3, 2023, approved by the University Steering Committee on May 17, 2023, published on January 30, 2024 with effect from September 1, 2024

Section 1 Reference to Other Regulations

¹These regulations determine the binding module titles, graded exams, and credit points of language modules at the Faculty of Business Management and Social Sciences. ²They contain the essential binding provisions for the completion of language modules in conjunction with the Study Regulations and the Program-Specific Examination Regulations of the respective degree program, the offer of the Center for International Students (CIS) in the area of German, and the General Examination Regulations of Osnabrück University of Applied Sciences.

Section 2 Type and Scope of Exams

The type and number of graded exams and the associated examination requirements are set forth in the Appendix.

Section 3 Admission to a Level

To be admitted to a particular level, students must show proof of having passed the previous level or be admitted through the placement test.

Section 4 German Language Modules

German modules are additional modules and can only contribute to the degree by international degreeseeking students in accordance with the curricular requirements of the Study Regulations.

Section 5 Transitional Arrangement

¹Students who enroll by the summer semester 2024 can take the language modules under the previous Examination and Study Regulations by the end of the winter semester 2028/2029.

Section 6 Entry into Force

¹These regulations shall enter into force on the day after their publication in the Official Gazette of Osnabrück University of Applied Sciences with effect from the winter semester 2024/2025.

PFP-5) The portfolio exam is worth 100 points and consists of a 30-minute written exam (K30), a written assignment (HA), a presentation (PR), and an oral exam (M). Each element is weighted with 25 points.

PFP-6) The portfolio exam is worth 100 points and consists of a one-hour written exam (K1), a presentation (PR), and two oral exams (M). Each element is weighted with 25 points.

PFP-7) The portfolio exam is worth a total of 100 points and consists of two written exams (20 minutes each), a written exam (15 minutes), a presentation, and an oral exam. Each written exam (20 minutes each) is weighted with 20 points. The written exam (15 minutes) is weighted with 10 points. The presentation and the oral exam are each weighted with 25 points in the calculation of the final grade.
