### How to deal with national risk areas

However, as soon as you have symptoms that might indicate a corona virus infection, or if you have been quarantined by the authorities because you have been in touch with an infected person, you may not come to the campuses of the university anymore. In case you have symptoms and are unsure what to do, please contact the Center for International Students. We will advise you on what to do. Should there be changes in the regulations, we will inform you immediately. ### **Hygienic Rules in Laboratories**

## Reminder: Registration Procedure in Face-to-Face Classes

We have already informed you that in all face-to-face classes, the contact data of all participants must be stored.

Please register for the class by scanning the QR-code on your table and by filling out the form that pops up on your smartphone. ### Reminder: Obligation to wear Protective Face Masks in all Buildings!

When walking through any buildings of the university, wearing a protective face mask is mandatory! In addition, you must keep a distance of at least 1.5 meters from other persons. When you sit down at a desk, you may put down you mask only if distances to all other persons can be kept.

Therefore, you are obligated to wear a mask in any and all situations where a minimal distance of 1.5 meters is not possible. In all waiting areas, the mask is mandatory. Waiting areas are for example:

- Entrance halls of libraries
- Lingen Campus inside the hall
- Entrance halls (e.g. Building AB)
- all corridors when you are waiting for an office hour
